Types of Annual Passes

GUEST:

- Single \$2,500 (Unlimited golf 7-day pass)
- Family \$3,300 (Immediate family members consisting of head of household, spouse, children 22 YOA and under which live in the same household and/or can be claimed as a dependent)
- Weekday M-F \$1,800 (Individual Use -Limited to Monday-Friday, weekends and holidays are NOT included)
- Junior (Guest/Associate) \$500 (June-August only) 18 YOA or under

ASSOCIATE:

- Single \$2,000 (Unlimited golf 7-day pass)
- Family \$2,500 (Immediate family members consisting of head of household, spouse, children 22 YOA and under which live in the same household and/or can be claimed as a dependent)
- Senior Single 5 day \$1,400 (Age 60 and older)
- Senior Family 5 day \$2,000 (Immediate family members, Spouse, children 22 YOA and under which live in the same household and/or can be claimed as a dependent.)

CORPORATE: (limited to 5 total)

2. Discounts on select items in the golf shop (15% off apparel...shirts, shorts, outerwear, headwear)
